## New deals see Metroplex Tweed sale remains in Westgate moving ahead

TWO more development sites worth \$4.35 million in total have been snapped up at a Wacol industrial park where the first buildings are now under construction.

High-end Italian roller door manufacturer, BMP Doors, has purchased a 3096sq m lot in the GPT Group and Metroplex-developed Metroplex Westgate estate, while a Brisbane-based commercial food product supplier has secured a 1.2ha site in park.

BMP Doors has started construction on a 1700sq m warehouse on the site, which is expected to be complete soon.

Construction on a 5000sq m warehouse on the other lot will soon start, with completion slated for early next

Italian-based BMP Doors Australian arm previously operated from a 300sq m warehouse in Herston which its director Zack Jones said was "bursting at the seams".

"Business is really ramping up, driven by demand from the logistics, cold storage, pharmaceutical and mining indus-

This week Garda Capital announced the purchase of the 3.274ha AB Volvo facility for \$35.25 million.

Volvo Group Australia have pre-committed to a 10-year lease for what will be their new Australian head office.
